Veterans' Benefits Checklist

The following is a checklist of several veterans' benefits and services. You can learn more about these programs by checking with a DAV National Service Officer (NSO) or Transition Service Officer (TSO). Your NSO or TSO can then help you apply for benefits to which you may be entitled. The services of DAV are absolutely free of charge.

If you don't know how to get in touch with your DAV NSO or TSO, write to the address on the back of this brochure or log onto www.dav.org for a directory of DAV National and Transitional Service Offices. Remember, the DAV isn't a government agency. We're a nonprofit organization of more than 1.2 million wartime disabled veterans. Our approximately 260 NSOs and TSOs, working in 88 offices nationwide, have only one commitment - helping you and your family get all the rights and benefits your sacrifices earned.

Service-Connected Disability Compensation

- ☐ Entitlement based on disability incurred in or aggravated by military service
- Disabilities are rated according to severity, with compensation increasing as the percentage of disability rises
- ☐ Disability ratings are generally protected once they've been in effect for 20 years
- ☐ Statutory awards in addition to basic compensation for certain severe losses
- ☐ Service-connection of certain disabilities is presumed under certain circumstances

Special Benefits For Certain Disabled Veterans

- ☐ Financial assistance for an automobile or other conveyance for veterans with certain severe physical disabilities
- ☐ Automobile adaptive equipment grant
- ☐ Specially adapted housing for certain severely disabled veterans

 Clothing allowance for veterans whose service connected prosthetic devices or topical medications, tend to destroy clothing

Nonservice-Connected Pension

- ☐ Eligibility is based on disability, wartime service, and certain income criteria
- ☐ Special monthly pension based on certain severe disabilities

Benefits For Widowed Spouses And Orphans

- □ VA compensation and pension payments end when the veteran dies
- □ Dependency and Indemnity Compensation for the survivors of veterans who die due to service-connected causes, as well as veterans whose 100% service-connected disability rating had been in effect for 10 years prior to death, five years from date of discharge from military service, or 1 year for POWs.

- Nonservice-connected death benefits for veterans' survivors when specific income requirements are met
- □ Burial benefits
