

**2014 Jesse Brown Memorial  
Youth Scholarship Program  
Nominees Sought**



Dear Commanders and Program Managers:

DAV is again pleased to announce the **2014 Jesse Brown Memorial Youth Scholarship Program** designed to encourage youth volunteers to become active in the Department of Veterans Affairs Voluntary Service (VAVS) Program and/or DAV's Local Veterans Assistance Program (LVAP).

The DAV Jesse Brown Memorial Youth Scholarship Program is awarded annually to outstanding youth volunteers who are engaged in the VAVS and/or LVAP program. First place prize includes a \$20,000 scholarship and an expense paid trip to DAV's National Convention with his/her parent/guardian for the award presentation. The second place prize consists of a \$15,000 scholarship and third place prize is a \$10,000 scholarship. There are two fourth place prizes consisting of \$7,500 scholarships each, and three fifth place scholarships at \$5,000 each.

Candidates for the scholarships must be age 21 or younger and must have volunteered a minimum of 100 hours during the previous calendar year. All volunteer hours must be credited to DAV through the VAVS or LVAP program. The scholarships can be used for any accredited institution of higher learning, to include universities, colleges, community colleges, or vocational schools, etc. In addition, each recipient must utilize the entire scholarship prior to reaching age 25, or within six years of receiving the scholarship, whichever is later. Employees of DAV's national organization and their families are eligible for consideration for the scholarships.

It is extremely important to engage and involve youth in the benefits of volunteering, so we ask for your continued support of this scholarship program. It is requested that all DAV Department Commanders and Voluntary Service Program Managers select a youth volunteer from your facilities or within your jurisdiction for this award by completing the attached nomination form. **Nominations must be received no later than Friday, February 7, 2014.**

Nominations may also be received from DAV Chapters, DAV Auxiliary Units and all DAV and DAVA Representatives and Deputy Representatives. Department Commanders with more than one VA facility in their state may submit one youth volunteer from each facility. DAV Departments, Chapters, or Auxiliary Units with youth meeting eligibility requirements may submit nomination forms for youth volunteering through LVAP.
