Joseph Lemay and Shamala B. Capizzi

Joseph Lemay, national service office supervisor and Shamala B. Capizzi, national service officer in the Washington, D.C. office, have been appointed as associate national legislative directors at DAV's Washington Headquarters.

In this capacity, Lemay and Capizzi will support efforts to advance a broad range of federal legislative goals and policies to assist injured and ill veterans and their families.

Lemay is a native of Mashpee, Massachusetts, and served in the Army from 1990-1994 and 1997-2014, achieving the rank of sergeant first class. He served as a logistical specialist and his service included three deployments to Iraq and one to Afghanistan.

Lemay began his DAV career in 2018 as a national service officer in Decatur, Georgia. In 2022, he was first promoted to assistant supervisor of the Washington, D.C. national service office before being promoted to supervisor there later that year.
