Jon Retzer

Assistant National Legislative Director Jon Retzer has been appointed Deputy National Legislative Director for Health at our Washington Headquarters.

In this capacity, he will support DAV's advocacy efforts regarding care provided by the Veterans Health Administration in the Department of Veterans Affairs and work to advance legislation and policies critical to the positive healthcare outcomes of disabled veterans.

A native of Fridley, Minnesota, Jon served in the U.S. Army infantry from 1991 to 1995 and continued his service with the Army National Guard until his medical separation in 1999.

Jon's DAV career began in 2003 as a National Service Officer Apprentice in St. Paul, Minnesota. He was first promoted to Assistant Supervisor of the Fort Snelling National Service Office and then to Supervisor. In 2017, he was appointed Assistant National Service Director, where he served until his appointment as Assistant National Legislative Director in 2022.

He is a life member of Chapter 39 in Anoka, Minnesota. He and his wife, Jan, reside in Crofton, Maryland, with their two sons.
