#### WHAT IS DIC?

Dependency and Indemnity Compensation (DIC) is a taxfree monetary benefit paid to eligible survivors of military service members who died in the line of duty or eligible survivors of veterans whose death resulted from a servicerelated injury or disease.



#### Lowering DIC Remarriage Age

- Johnny Isakson and David P. Roe, M.D. Veterans Health Care and Benefits Improvement Act
- Lowers the DIC Remarriage Age from 57 to 55
- Signed by the President in January 2021
- DIRECTLY due to you efforts



#### LOWERING DIC REMARRIAGE AGE

- Are we done?
- Resolutions No. 360- "strongly supports legislation that improves and reforms DIC benefits to include... lowering the remarriage age for survivors of disabled veterans."



#### Increase DIC Amount

- DIC is a monthly benefit paid to eligible survivors/dependents
- Less than 50% from what a veteran who is 100% receives
  - From \$3,321 → \$1,357
- Loses approximately \$24,000 a year
- Increase DIC benefits to 55% of a 100% disabled veterans compensation



#### Reduce the 10-Year Rule for DIC

- A veteran must be rated 100% for 10 years for DIC eligibility
- This time frame is non-negotiable and negatively impacts:
  - > Spouses who gave up their careers
  - Dependent Children
  - > Caregivers
- Congress should pass legislation that reduces the 10-year rule



#### WHAT IS BEING DONE?

- Caring for Survivors Act of 2021
  - S. 976: Introduced by Sen. Tester in March 2021
    - Senate Veterans Affairs Committee discussed in hearing in April
    - Currently 6 Co-Sponsors
  - H.R. 3402: Introduced by Rep. Hayes in May 2021
    - Currently Co-Sponsors

# What is Dependents' Educational Assistance (Chapter 35)?

- Chapter 35 provides education and training opportunities to eligible dependents of certain veterans for up to 45 months.
- Who is eligible?
  - $\circ$  If you are a spouse
  - Child, between the ages of 18 and 26
- Of a veteran who:
  - $\,\circ\,$  Died or is permanently & totally (P&T) disabled as
  - the result of a service-connected disability
    - A veteran who died from any cause while 100% P&T



#### **Delimiting Date for Chapter 35** (SURVIVORS' AND DEPENDENTS EDUCATIONAL ASSISTANCE)

- Recipient of Ch. 35 has 10 years to finish program
- Indifferent to caregivers, family obligations, & extenuating circumstances
- Remove the 10-year delimiting for Ch. 35

#### What is being Done?

- H.R. 2327, To Amend Title 38, U.S.C., to eliminate the time period for eligibility under Survivors' And Dependents' Educational Assistance Program of Department of Veterans Affairs
  - Introduced in April 2021 by Representative Mace
  - Currently I Co-Sponsor
    - Eligibility Date is on or after August 1, 2022



### **Require COVID-19 Medical Opinions**

- As of June 2021, over 12,000 veterans have died from COVID-19
- Certain SC conditions have proven to exacerbate COVID symptoms
- Veteran families may be denied important survivor benefits
- Enact legislation that would require the Secretary of the VA to seek a medical opinion when a service-connected veteran dies of COVID-19



#### WHAT IS BEING DONE?

- Ensuring Survivor Benefits During COVID-19 Act of 2021
  - S. 89
    - Introduced by Sen. Sinema in January 2021
    - Currently has 18 Co-Sponsors
    - Passed out of SVAC on June 24<sup>th</sup>!
    - Passed by the Senate on July 22<sup>nd</sup>!!!
  - H.R. 746
    - Introduced by Rep. Davidson in February 2021
    - Currently has 15 Co-Sponsors
